- **YOU MUST SUBMIT PHOTO**. Entries received without a photo will be marked as pending/incomplete and is not considered eligible until a photo is submitted. The photo should have a minimum resolution of 300 dpi and maximum resolution of 600 dpi
- The photo may be sent as a printed photo, but preferably on a c.d. If your film is selected for the festival, this is the photo that will be used in the program book.
- You may send a self-addressed stamped postcard, if you'd like a receipt for your entry.
